

MORE FLOYD FAMILY FUN!

I have previously documented the seemingly endless indications that Perry and Norma Floyd (and their families and associates) have been operating an extensive organized crime ring for decades. This information is available in “Middle American Mafia: Organized Crime Families in Oklahoma and Beyond” and subsequent documents available at www.middleamericanmafia.com. This document is a continuation of my efforts to illustrate the overwhelming connections between the Floyd family and organized crime.

OLD BUSINESS

A few of the many subjects which I have addressed in previous documents are: the disappearance/murder of JaRay Wilson from Weatherford, OK; animal mutilations connected to the Floyd family, especially Perry Floyd; and Perry Floyd’s suspicious interactions with a higher-ranking officer in the leadership of the Oklahoma National Guard. I have since collected or recalled new information about each of these topics that seems highly relevant.

JaRay Wilson

16-year-old JaRay Mickell Wilson disappeared from Weatherford, OK, in October of 2012. Police initially stated that they believed JaRay Wilson had been sold into human trafficking and was being held in Oklahoma City. By October of 2013, I had distributed and published on my website the document that listed the many seeming connections between the JaRay Wilson case and the Floyd family, the majority of whom live just a few minutes’ drive away from Weatherford, in Thomas, OK.

Oklahoma-based private investigator James “Tommy” Bottoms – who admitted that he had known Perry (aka “B.J.”) Floyd and his wife Norma Floyd for decades – supposedly volunteered to work on the JaRay Wilson case for free. Around the same time, Tommy Bottoms also **just happened** to “volunteer” to investigate two other long-standing cold cases that I had connected back to Perry Floyd in the same document – specifically, the disappearance of Sandy Rea from Shawnee in 1984, and the murder and disappearance of Paul and Melody Jones of Earlsboro in 1983. It seemed as if Tommy Bottoms had some vested interest in “disproving” the information I had presented as fast as possible, and it is highly likely that Norma Floyd hired this private investigator herself in secret.

Just a few months later, JaRay Wilson’s body had been found after police received a tip from a “confidential informant.” In December of 2012, a 19-year-old man named Tucker McGee was arrested for the murder of JaRay Wilson. Another 19-year-old man and a juvenile have since been charged as accessories to this crime. Oklahoma law enforcement seems to have a pattern of “solving” crimes almost immediately whenever Perry Floyd and/or his family and associates are implicated, and this behavior reeks of widespread corruption and cover-ups.

Police have changed their theory about the motivation behind JaRay Wilson’s murder from human trafficking to “drug-related.” It seems highly unlikely that three teenage boys were running a drug ring large enough to require the execution-style murder of a teenage girl on their own. But like so many

other cases before, it appears these young men may be “taking the fall” to divert scrutiny away from their older, higher-ranking cohorts in the Floyd family’s organized crime syndicate.

I went to Harrah Public Schools with a boy named Shawn McGee. Perry Floyd knew Shawn McGee’s father very well. Shawn McGee’s father was my elementary school basketball coach for three years. In fact, Coach McGee’s team was an unofficial “second-string” team that had been started at Perry Floyd’s request. This team was composed of only myself and five other players, so Perry Floyd and “Coach McGee” interacted often and heavily during this time period, with Perry Floyd sometimes acting as unofficial assistant coach.

Tucker McGee, the suspect in JaRay Wilson’s murder, bears a striking resemblance to Shawn McGee and his father, Coach McGee. It is highly likely that they are somehow related, which would further connect the JaRay Wilson case to a known associate of Perry Floyd.

Animal Torture/Mutilations

I have previously written briefly about Perry Floyd’s gleeful torture and murder of various animals. Two other important examples of this specific kind of cruelty are almost definitely also related to Perry Floyd.

The first involves the bizarre murder and ritualistic placement of 13 cows in Perry Floyd’s current hometown, Earlsboro, OK. From the “Notable Events” section of the Wikipedia.org entry on Earlsboro:

“1998 - A bolt of lightning struck a hickory tree in a nearby field. The next morning, 13 dead cows were found forming a perfect circle around the split tree, leading both skeptics and believers to ask the question "How did they get there?" ”

When I originally found this information, I also found an article online that corroborated this story, although I could not locate it again with a more recent search. That article implied that the cows had died of electrocution, and that even if lightning had been the cause, someone still had to have dragged the corpses of these cows into the formation of a perfect circle around the tree.

Perry Floyd moved to Earlsboro in late 1997, just before this event occurred. Perry Floyd enjoyed shocking the cattle he owned with his commercial-grade cattle prod. But there are taser-wands and stun guns built to incapacitate much bigger animals with a much higher voltage. With Perry Floyd’s extensive connections to military-grade arms and weapons dealers, it would not have been hard for him to obtain a taser or stun-gun type weapon like this, and it would be entirely in keeping with Perry Floyd’s personality to “break in” such a weapon by murdering thirteen cows.

The fact that the cows were dragged into a perfect circle around the tree that had been struck by lightning seems bizarrely ritualistic or occult-related. Even the Wikipedia entry about this event, with its reference to “skeptics and believers,” seems to imply that a mystical, supernatural, or even “divine” power may have been involved in placing the dead cows around this tree. But this heinous act of animal cruelty is almost definitely the work of Perry Floyd.

Members of the Floyd family and the Claxton family have displayed knowledge of certain “folk magic” or occult-type beliefs in the past. I won’t go into full detail here, as that topic will require a lot of space when I do get around to explaining it. But anecdotally, Denver Claxton once warned me not to go toward one end of the half-mile stretch of rural dirt road that we lived on, because “Satanists” had been

mutilating stray dogs in some abandoned shacks nearby. Given Perry Floyd's proclivity for shooting at stray dogs, he could certainly have been one of the "Satanists" to whom Denver Claxton referred. Norma Floyd issued a similar warning not to venture to the other end of the same half-mile long dirt road, where she had supposedly seen a woman drowning baby chickens, because this horrific act meant that the woman was a "witch."

Norma Floyd and Denver Claxton seemed to equate animal murders and mutilations with occult animal sacrifices in a fairly confident, knowledgeable manner. And beyond warning me not to venture onto the properties where these animal killings were taking place, they didn't seem too shocked or concerned to be surrounded by "Satanists" and "witches." For a family who may have been involved in very similar murders of humans with heavy symbolic overtones and/or ritualistic resonances, the comfort and certainty with which they referred to these grisly occult practices is deeply disturbing.

Oklahoma National Guard

I have previously described the suspicious death of the son of one of Perry Floyd's superiors in the Oklahoma National Guard's 45th Infantry Division. I believe this man's last name may have been "Grizzle." He was described as a multi-millionaire who at one time owned one-quarter of the shares in the Sonic Corporation's fast food chain of the same name, as well as the Mission Tortilla company, and later, the CD Warehouse chain.

Norma Floyd told me that, prior to the death of this man's son, Perry Floyd and he had been fighting about some work-related disagreement. When this man's son turned up dead, Norma Floyd told me that "Perry had to put all those disagreements aside, because the Oklahoma National Guard was Perry's family."

The son's death occurred during a weekend that his parents were out of town, either celebrating an anniversary or a birthday. Norma and Perry Floyd attended at least one formal dinner with the Grizzles during this weekend getaway, along with many of the couple's other friends. I have several anecdotal reasons to believe that Norma Floyd faked having broken both of her arms, and that she wore false casts on her arms to this dinner. This faked catastrophic injury was probably designed to provide a solid alibi for Perry and Norma Floyd during the weekend that the Grizzles' son died, because Perry Floyd could claim to have been waiting on Norma Floyd around the clock while she was so debilitated.

CORRECTION I originally thought this family name was "Drexel." I was likely confusing the name with another family name – "Driskill" – which is the name of a family that associates with both the Floyd and the Grizzle families. NEW BUSINESS

Peggy Anne Sweeten

Peggy Anne Sweeten disappeared from Grove, OK, in January of 1998. Her disappearance is presumed to have involved foul play, and Peggy Anne Sweeten is presumed dead by law enforcement and her family.

In middle school, I spent the night at a friend's house on two occasions. That friend's name was Justin Sweeten. Justin Sweeten took a class with me in college, and he mentioned that his grandmother had disappeared without a trace. Peggy Anne Sweeten resembles Justin Sweeten, and she was about the right age to have been his grandmother, as she was 52 years old when she disappeared.

If Peggy Anne Sweeten is Justin Sweeten's missing grandmother, this is yet another missing persons case in which Perry Floyd knew or knew of the victim before the victim's disappearance. This case may also be another example of Perry Floyd's special interest in symbolically "punishing" me and/or people that were close to me.

A few years after Peggy Anne Sweeten disappeared, Norma Floyd told me that Perry Floyd had begun watching episodes of *King of the Hill*. Norma Floyd said it was his favorite new show. This was extremely out of character for Perry Floyd, who only seemed to enjoy westerns and golf in the decades that I lived with him. In fact, he hated cartoons aimed at adults and ranted about them specifically on several occasions. When I asked Norma Floyd why Perry Floyd suddenly liked *King of the Hill*, she said he just liked to turn the sound off and watch it in bed.

The pictures I found of Peggy Anne Sweeten show her to greatly resemble the fictional character of Peggy Hill from *King of the Hill*. Both women are named "Peggy," and both are matronly brunettes with golden, square-framed glasses and short, brushed-back, rounded hairstyles, worn high on top of the head, with bangs. The images below demonstrate their striking resemblance.



King of the Hill was only on for about a year before Peggy Anne Sweeten disappeared, so it is unlikely that she was targeted because of this strong resemblance to the character of Peggy Hill. But it is entirely likely that Perry Floyd enjoyed watching *King of the Hill* because the image of Peggy Hill allowed him to reminisce about another one of his real-life victims, Peggy Anne Sweeten.

Suspicious Death/Murders of Gay Men in Australia

The above web address links to a transcript of an investigative documentary about the suspicious death of a 25-year-old gay man from Australia named Scott Johnson. The transcript describes how Scott Johnson was likely pushed or thrown from a cliff that was a known meeting place for gay men. The article also refers to the Bondi Gay Murders, which are the similar murders of three other gay men at cliff-side gay meeting places in Australia in the late 1980s and early 1990s. All of these men were assaulted and murdered by being thrown off of cliffs.

The transcript states that Scott Johnson died in December of 1988. If Scott Johnson's death occurred in the first two-thirds of December of that year, Perry Floyd may have been in Australia on one of his so-called "business trips" at the same time. I recall that Perry Floyd took at least one trip to Australia in December. I believe it was either in 1988 or 1989. I recall this trip specifically because Norma Floyd could never tell me when Perry Floyd would return from these "business trips," and I hoped that Perry Floyd would stay gone through Christmas.

One of the movies that Perry Floyd watched on multiple occasions in the 1990s is the western *Quigley Down Under*, which is set in Australia. There is a scene in this film in which many indigenous people are murdered by being driven off of a high cliff. Perry Floyd used to rewind this scene over and over again when he watched the movie, and I believe that he was reliving some memory of actually murdering people by throwing them off of cliffs in Australia.

Perry Floyd might have committed the murder of Scott Johnson and possibly the Bondi Gay Murders simply because he is a sociopathic homophobe. But there could have been another motivation for the murders of gay men at gay meeting spots.

In the late 1980s and the 1990s, Perry Floyd visited Australia on "business trips" quite frequently. I have already discussed the crimes that seemed to coincide with several of the dates of these trips. I also pointed out some indications that Perry Floyd may have had assistance from corrupt Australian law enforcement and/or local organized crime contacts.

If a hypothetical American was running a legitimate business "empire," it might take extensive resources and effort to expand that business empire internationally, into a place like Australia. But if an American is running a highly *illegal* business syndicate, the process for moving your crime syndicate overseas is a lot simpler: Just expatriate a few of your thugs/criminal families, and have them go to work in their new home. Perry Floyd and Norma Floyd have many had several family members and acquaintances who have frequently travelled to and/or moved permanently to both Australia and New Zealand. In fact, the Floyd family has shown a multi-generational near-obsession with Australia, which I will discuss more fully later. All of this indicates that the Floyd family's organized crime ring has a significant presence in Australia themselves, and/or an extensive alliance with organized crime entities in Australia.

Perry Floyd is a raging homophobe. But there are indications that the Floyd family was running a homosexual prostitution ring/underage sex trafficking operation right alongside their mainstream sex trafficking operations, which were aimed at a heterosexual client base. In other words, Perry Floyd certainly has a violent hatred for homosexuals – unless those individuals are his paying customers.

The fact is, a homophobic culture directly promotes sex trafficking, because closeted homosexuals in a homophobic culture would definitely be more inclined to solicit prostitutes than out-of-the-closet homosexuals in an open and inclusive culture. Perry Floyd and/or his associates in organized crime in Australia may have been involved in propagating the wave of homophobic attacks and murders in Australia at this time. These violent attacks were said to be the work of local street gangs, and they almost certainly diminished the foot-traffic at the “known homosexual meeting places” that were being targeted. The men who visited these places likely had to look for sexual gratification elsewhere as a result, thus driving up the profits of organized crime’s homosexual prostitution rings and underage sex trafficking in the area.

James Floyd

One person who has definitely shown a lifelong interest in Australia is Perry Floyd’s father-figure, James Floyd. (I say James Floyd is Perry Floyd’s “father-figure” because I have reason to doubt that he is Perry Floyd’s biological father, although he is generally presented as such.) James Floyd supposedly had a job that was described vaguely as “in the oil business,” and he referred to his employer only as “the company.” When Perry Floyd first began travelling to Australia, James Floyd stated that “the company” often sent him to Australia as well.

From Wikipedia.org:

"Mr. Cruel" is the name given to an Australian murderer and rapist who attacked girls in suburban Melbourne in the late 1980s and early 1990s. His identity is unknown."

Mr. Cruel was described as having an odd way of talking. James Floyd once claimed to be able to “speak Australian,” and at his grandchildren’s prompting, he spoke in a fake Australian accent. The accent was not perfect by any means, but it was fairly close to a generic Australian accent. But even if James Floyd had a perfect Australian accent, it still would likely sound odd to a real Australian, because Australians and Americans use very different vocabularies and phrasings.

“Mr. Cruel” also used the word “Missy” in an odd and disturbing way during his torture and rape of the girls he abducted. James Floyd used to lift his granddaughters off the ground by their wrists, with their arms stretched out straight above their heads, and stare into their faces while he squealed a single word: “MISS-seeeeEYY!”

I have a vivid enough memory of this disturbing ritual that I can still do a good impression of it, with the volume and pitch starting out high and loud, tapering off in the middle, and rising again at the end of the drawn-out word.

“Mr. Cruel” also used a “rough neck brace” to shackle his victims to a bed. James Floyd supposedly had neck and back problems, and after an injury, he had to wear a neck brace for a long while.

Organized Crime as Rivals of National Intelligence Agencies

A few months ago I read an article about comments the Israeli Prime Minister made in a speech about organized crime. He stated that modern organized crime organizations were using many of the same

sophisticated techniques employed by the world's leading National Intelligence Agencies. I've already pointed out a three-decade relationship between Norma and Perry Floyd and an agent of the Oklahoma City Office of the FBI, Gary Johnson. I've also pointed out the evidence suggesting Perry and Norma Floyd had a hand in planning and executing the bombing of the *Alfred P. Murrah Federal Building* in Oklahoma City in 1995. And I've pointed out the high probability that Perry Floyd, as a purchasing officer for the Oklahoma National Guard, was engaged in illegal arms dealings with organized crime groups internationally. It is therefore highly likely that the Floyd family's organized crime syndicate has contacts in other National Intelligence Agencies.

I have suspected that Perry Floyd has some contact(s) in the CIA for a while now. This was originally just a suspicion based on the fact that whenever the CIA was mentioned on a news report or in conversation in the presence of Perry Floyd, he would go completely quiet. Perry Floyd's eyes would narrow into slits, and his ears would literally flex backwards a little as he strained to hear whatever was being said.

This suspicion was confirmed for me several months ago, when I learned that many "old timers" – like James Floyd – refer to the CIA as "the Company." As I said before, James Floyd only ever referred to his place of employment as "the company" in my presence.

One year when I was still very young, I drew and framed Christmas-themed pictures for all my grandparents as gifts. I drew a four-pointed star that was meant to be the North Star. When my mother saw it, she insisted that I add twelve more points to the star to make it a sixteen-pointed star. She then insisted that James Floyd should be the grandparent who received this drawing as a gift. When this gift was opened, James Floyd's wife, Lorene, exclaimed excitedly that it was a sixteen-pointed star. The Floyd family laughed and "ooo'ed" and "ahhh'ed" and said how nice it was. I had no idea why they were so elated that I had drawn a sixteen-pointed star for James Floyd – until recently, when I learned that the symbol of the CIA is a sixteen-pointed star.

James Floyd once claimed to be "distantly related" to the gangster known as "Pretty Boy Floyd." James Floyd even claimed that money or gold accumulated by Pretty Boy Floyd in bank robberies had been stashed "under a rock or tree" on land in Oklahoma owned by a relative, an elderly woman they referred to as 'Aunt Desi.' Pretty Boy Floyd is known to have committed a range of crimes in Oklahoma and many of the surrounding states, just as the modern-day Floyd family seems to be doing.

If James Floyd was telling the truth when he said that he was related to Pretty Boy Floyd, it would mean that the Floyd family has been heavily involved in organized crime for at least five or six generations, instead of the three generations that I have presented evidence on previously. But three generations – and certainly five or six generations – is plenty of time to develop extensive contacts in all areas of law enforcement and national security, including the CIA.
